#### **DIRECTIONS FOR USE**

Add this product when the spa is not in use. Broadcast product into spa with pump and filter running. Break up or brush any visible, undissolved residue remaining on spa surfaces. Do NOT add more than 30 grams of **BioGuard SPA Aquality** per 1000 litres at any one time.

Your **BioGuard Approved Retailer** will advise you the exact dosage rate needed for your spa. Allow water to circulate for at least 2 hours before testing pH and TA, then reapply if required. Do not add near metal fittings.
