DIRECTIONS FOR USE

IMPORTANT: For best results, NEVER add more than the recommended dose at any one time. Give each treatment at least 24 hours to work before repeating the application.

CLEARING CLOUDY WATER:

1. Clean filter and pump strainer.
2. Operate pump continuously during treatment.
3. Add 10mL of **BioGuard SPA Crystal Clear** per 1000 litres of water. Pour directly into water.
4. Backwash filter if pressure reaches maximum reading as specified by the manufacturer.
5. Repeat treatment if water has not cleared after at least 24 hours of continuous filtration.

MAINTENANCE APPLICATION:

To maintain sparkling clear water in your spa, add 5mL of **BioGuard SPA Crystal Clear** per 1000 litres of water once a week.

One level capful holds approximately 10mL of BioGuard SPA Crystal Clear.
